

Revolutionary War Soldiers of Jessamine County, KY

Adams, Benjamin*	R. W. S. applied for his pension in Jessamine County, Kentucky, June 4, 1818, at the age of 67 years. He had enlisted in the Revolutionary War in Orange County, Virginia or Norfolk County, Virginia in the spring of 1776. Mentions: Joseph Spencer and John Nelson, who served with him in the war, (Pension No. S. 35169
Adams, James*	
Allcorn, George*	R. W. S. applied for a pension in Bartholomew County, Indiana, March 13, 1833, at the age of 72 years. He was born on the Pedee River in North Carolina in 1760. He volunteered into service in Fairfield District, South Carolina. Note: George Allcorn lived in Jessamine County until 1806, when he moved to Clay County, Kentucky. He came back to Jessamine County in 1824 and lived about two years before moving to Bartholomew County, Indiana. George Allcorn died December 27, 1833.
Anderson, William	Capt. William Anderson, Continental Line, was born 1750 in Augusta County, Virginia and died on May 26, 1817 in Jessamine County, Kentucky. He was appointed Captain in the Augusta County Militia in 1776. His company was involved in many excursions into the wilderness west of the settled areas of Virginia. He obtained a 400 acre settlement and a 1,000 acre preemption by making an entry at Bryant's Station, Kentucky in 1779 and participating in a survey of the land on West Hickman Creek in 1783. He appears in the first tax lists of Fayette County, Kentucky, the parent county of Jessamine. He and his second wife, Catherine Blair, had 11 children. Some are buried in the Anderson Family Cemetery on his property, where his Revolutionary War Military Stone was placed by the Jessamine County Historical Society in 2002. Capt. William Anderson sold 300 acres of his patent to William Marshall in 1793. Anderson's Spring Branch, described on his survey, became Marshall's Branch, and is still known by that name. Capt. William Anderson and his wife, Catherine, appear in the early records of Walnut Hill Presbyterian Church, which are contained in the Shane Papers, Draper Manuscript Collection. The William Anderson patent on West Hickman Creek remained in the family until the youngest son, Oliver Anderson, sold the last tract in 1848. Source: Mary Alice Farrell
Arnspiger, Paul*	Paul Arnspiger was an attendee at the 4 th of July celebration west of the Alleganys. This was hosted by Col. William Price in 1794. He was most likely a member of the Bedford County, Pennsylvania Militia, although no record has been found. He has been found on two rosters from 1789 in Bedford County, Pennsylvania. He died in Jessamine County, Kentucky on July 18, 1822. No pension record has been found for this veteran.

Barry, John	R. W. S., came to Jessamine County in 1796. He died there on June 1, 1826, at the age of 84 years. He was the father of Maj. W. T. Berry.
Barton, John	
Biswell, John	R. W. S., came into open court on September 19, 1820. He states that he is sixty years old and a resident of Jessamine County. He enlisted in the Revolutionary Service at Pittsylvania Courthouse, Virginia. He enlisted in the Sixth Virginia Regiment under Col. Butler. He thinks that it was sometime in March, 1776 or 1777. He continued to serve until he was discharged at Valley Forge. He, again, enlisted in Hillsburgh, North Carolina, where he served another three and one half years. He served in the Battle of Guilford's Courthouse and the Battle of Eutaw Springs. Mr. Biswell lists his property as: owning one half acre of land worth \$20.00; one pony worth \$10.00; one sow and six pigs worth \$7.00; some fowl worth \$1.00; and one axe worth \$2.00. He goes on to say that he had no one in his family but himself and that he had been a cripple for several years, and can work very little in tending his little garden. Note: John Biswell was living in Fayette County, Kentucky when he first applied for a pension on May 18, 1818, giving his age as 60 years old at the time. (Pension No. S. 35191)

Bruster Sr., James	James Brewster (1720-1808), a patriot of Virginia, being too old for active service, gave his loyal and increasing support to aid the Army. He was born in Ireland and died in Jessamine County, Kentucky. (also No. 159172)
Bryan, Daniel Boone*	R. W. S., was living in Jessamine County, Kentucky when he applied for his pension on February 18, 1833. He was 75 years old at the time. He said he was born in Rowan County, North Carolina on February 10, 1758. He enlisted into service in July or August of 1776 or 1777. He stated that he moved to Kentucky in the spring of 1779 with his father, William Bryan, and his brother, Samuel Bryan; that they lived at Bryan Station; the Indians killed his brother, William Bryan, in 1780. Mentions: his brother, Samuel, living in Marion County, Indiana in 1833. Also mentions two of Daniel's sons, Daniel Bryan Jr. and Thomas Bryan. (Pension No. S. 1172) Note: Daniel died on February 28, 1845. His wife, Elizabeth, was born on November 13, 1761. She died on January 29, 1833. This was Daniel Boone Bryan that was a nephew to Daniel and Rebecca Boone. Daniel Bryan converted John Lewis' old grist mill into the first and only

	paper mill in Jessamine County. Note: Daniel B. Bryan died in 1845.
Burk, Samuel	R. W. S. was living in Jessamine County when he applied for a pension on August 20, 1832. He was 75 years old at the time. He had enlisted into service in Culpepper County, Virginia, in 1775. Samuel and his wife, Mary, were married in Fauquier County, Virginia, on September 2, 1786. They moved to Kentucky about 1795. Samuel Burk died on March 16, 1841, in Shelby County, Kentucky, where he had been living about three years. Mentions: children and dates of birth. (Pension No. W. 2912)

Campbell, Robert*	R. W. S. was living in Jessamine County when he applied for a pension on December 17, 1832. He gave his age as 71 years at this time. He had enlisted into service in Botetourt County, Virginia in 1777. His widow, Katy, applied for his pension on May 3, 1853, giving her age as 87 years, 7 months old at the time. Mentions: Jane Wilmore, James Wilmore, Thomas Wilmore, Nather Campbell, Jacob Campbell, Robin Campbell, and Robert Campbell. (Pension No. W. 6621)
Carothers, James	R. W. S., applied for a pension in Jessamine County on September 2, 1818, at the age of 65. He had enlisted into service in North Carolina on May 4, 1776. James Carothers died on July 11, 1855. (Pension No. S. 10426) Note: Buried near Keene, on Highway 169, Cecil Perkins farm.
Carrol, John*	R. W. S. applied for a pension in Jessamine County on August 20, 1832. He had enlisted in the Revolutionary War in Charles County, Virginia in 1776. John died in Jessamine County on February 12, 1842. (Pension No. S. 30913)
Cassell, Abraham*	R. W. S. was living in Jessamine County when he applied for his pension on February 11, 1832. He was 77 years old at the time. He had enlisted into service in Frederick County, Maryland in 1776. Abraham Cassell died on May 26, 184. His widow, Catherine Lingenfelter Cassell, applied for his pension on December 21, 1844. She was 84 years old at the time. She and Abraham were married in Frederick County on April 24, 1782. Mentions: some of their children and gives dates of birth. (Pension No. W. 2916) Abraham died in Fayette County, Kentucky.

Crowder, Sterling	R. W. S. applied for his pension in Jessamine County on May 25, 1818. He was 59 years old at the time. He had enlisted in the Revolutionary service in Pittsylvania County, Virginia in 1777. Sterling Crowder died on January 18, 1834.

Donner, George	Did not serve, but gave Patriotic Service in North Carolina. Died on June 17, 1844 in Springfield, Sangamon County, Illinois. Burial site unknown. From JoAnn Schmidt

Earthenhouser, Conrad	R. W. S. applied for a pension in Jessamine in 1832. He gave his age as 88 years old at the time. He said he was born in Germany in May of 1755. He came to America as a soldier to fight the Americans. He deserted the British in 1779 and joined the United States Army. He enlisted at Honover County, Virginia in 1779. He goes on to say that after the war, he lived in Washington County, Maryland until 1801, when he moved to Jessamine County, Kentucky. (Pension No. R. 3199) Note: Buried on Short Shun Road at the old Jessamine Creek meetinghouse.
Fain, William	R. W. S. applied for his pension in Jessamine County on May 20, 1835. He was then 73 years old. He had enlisted into service in Patrick County, Virginia in September of 1781. Mentions: George Stults and Richard Fain of Adair County, Kentucky, who served in the war with him. (Pension No. R. 3422)

Mentions: John Beham of Mercer County, Kentucky and Joseph Spencer of Gallatin County, Kentucky. Both had served with him in the war. (Pension No. S. 35969)

Holloway, James	Lieutenant in the 8 th Regiment, Virginia Troops from 1776 to the end of the Revolution. Warrant No. 1715 for 200 acres of bounty land was issued on March 1, 1831 to his heirs on account of said service. He died September 16, 1829 in Jessamine County, Kentucky, leaving a widow, Martha. On December 13, 1831 the following children were alive: Mary, wife of Hugh Crutcher; Julia, wife of Barnett Rucker; Patsey, wife of James Flourney; John; Spencer; and Samuel. Thomas was a son that died

	prior to this date and left the following children: Martha Clark, William, James, Elizabeth, and Jane. Information from Jo Ann Schmidt

Jenkins, William	R. W. S. applied for a pension in Harrison County, Kentucky on March 16, 1819, giving his age as 53 years. He had enlisted into service in Orange County, Virginia. William Jenkins died on July 17, 1830. His widow, Kesiah*, applied for his pension on November 12, 1838. She gave her age as 72 years. She stated that she and William were married in Spotsylvania County, Virginia on December 1, 1783. Mentions: children (Pension No. W. 2944
King, Henry	
King, Jeremiah*	R. W. S. applied for a pension in Jessamine County on February 17, 1823 at the age of 64. He had enlisted into service in Branswick, New Jersey on May 22, 1776. He was discharged at Middlebrook, New Jersey on April 4, 1779. He transferred his pension from Jessamine County, Kentucky to Clark County, Missouri on November 10, 1832. In 1843, he moved back to Jessamine County, stating "the climate of Missouri did not suit his constitution". Mentions: George Spaulding of Washington County, Kentucky, who served with him in the war. Mentions Perry King in Florida. Also mentions William Lason, Joseph Wallace, and Henry Horine. (Pension No. _S. 36032) Note: In 1804 Jeremiah King and George Watts were co-partners in the ferry at the mouth of Hickman Creek.
Knight, James	R. W. S. applied for a pension in Jessamine County on October 29, 1830 at age 81 years. He enlisted into service in Frederick County, Virginia in 1775 or 1776. James Knight died on November 3, 1831. His widow, Elizabeth, applied for his pension on May 22, 1839. She stated that she and James were married on October 21, 1783. Mentions: Bible records; gives children and dates of birth. (Pension No. _W. 2946) Note: Buried: Almahurst Farm, Highway 169; Born: March 9, 1750; Died: October 21, 1831; Wife: Elizabeth. Elizabeth was born on January 26, 1764 and died on October 22, 1854.
Lamme, Samuel	R. W. S. moved from Jessamine County to Harrison County, Kentucky in 1801. He died there in December, 1824 at the age of 75 years.
Lewis, John	
Lloyd, William	R. W. S. applied for a pension in Fayette County, Kentucky in 1818, giving his age as 70 years. He said he enlisted in Culpepper County, Virginia and that he had lived in Franklin County, Kentucky. (Pension No. S. 36049)
Lockett, James	
Madison, Gabriel*	R. W. S. was born in Augusta County, Virginia. He was the son of John Madison and Agatha Strother. He was in the Battle of Blue Licks. Gabriel served on the first court in Jessamine County. He was a brother to Governor George Madison and a second cousin of President James

	Madison. He had served as a Colonel in the Revolutionary War. Gabriel married Mariah Lewis, a daughter of David Lewis of Albemarle County, Virginia. He died in Jessamine County on July 27, 1804. He was elected Representative of Fayette County, in 1792, to the first Kentucky Legislature. The first court ever held in Kentucky was at Harrodsburg on January 16, 1781. Gabriel Madison was commissioned to serve on this court on January 21, 1783. Note: lived on Curd's Road, 6 miles from Lexington in 1792.
Marshall, William	The cemetery in which he is buried was found on Vince Road, Jessamine County, Kentucky. His grave stone is still readable.
Martin, James	R. W. S. was living on the Jessamine and Fayette County line when he applied for a pension on March 14, 1833. He gave his age as 74 years. He entered into service in Albemarle County, Virginia. He also served in Wayne's Indian War. He said he had been in Kentucky for about 47 years. James Martin died in 1848. Mentions: children. (Pension No. S. 31236)

McGee, John	R. W. S. was living near the corner of the Fayette, Woodford, and Jessamine County lines when he applied for his pension. He said he was born in Middlesex County, New Jersey, six miles from Princeton, on March 20, 1761. He enlisted into Revolutionary War service in Middlesex County. Mentions: Martin Heogland, of Fayette County, Kentucky, who served with him in the war. (Pension No. S. 1230)
McGraw, Christopher	R. W. S. came into open court on January 15, 1821. He stated that he was 60 years old and had enlisted in the Revolutionary War at Winchester, Maryland. He stated that in 1777 he was a drummer in the 2 nd Maryland Regiment, in which he served three years. He goes on to say that he was discharged at Frederick Town, Maryland. He said that he was in the battles of Germantown, Brandywine, Monmouth, and was at the Battle of Guilford's Courthouse. He served in Saint Clair's Defeat. In this battle he lost one eye and was wounded in the right leg. McGraw swore that he owned no property of any kind except the clothes that he was wearing. He said his occupation was still drumming, when he was able, for the State Militia. For this, he earned little pay. Note: Saint Clair's Defeat occurred on November 4, 1791, after the Revolutionary War had ended. This battle was against the Ohio Indians and fought near Fort Wayne. Of the several thousand soldiers who had volunteered for this expedition, less than eight hundred survived the ordeal. McGraw was one of the lucky ones.

Miller, Francis	R. W. S. applied for a pension in Jessamine County on August 29, 1833 at the age of 85. He enlisted into service in Culpepper County, Virginia in 1780. He moved from Culpepper County to Jessamine County, Kentucky in 1795. Francis Miller died on October 19, 1839. His widow, Elizabeth, applied for his pension on April 28, 1845. She gave her age as 82 years.

	Mentions: John Freeman, a brother to Elizabeth Freeman Miller, and Freeman's wife Rebecca; Bible record gives children and dates of birth. (Pension No. W.8459) Note: Buried on Snowden Lane, Dean Farm. Francis Miller, born: 1748; died on October 26, 1836. Wife, Elizabeth, buried here also; born: 1769; died on April 5, 1845.
Miller, Nicholas	R. W. S. applied for a pension in Jessamine County on August 21, 1820, giving his age as 80 years old. He enlisted into service in Lancaster County, Pennsylvania, in the 9 th Regiment. He was in the Battle of Brunswick and discharged near Morristown, New Jersey.
Moore, Daniel	R. W. S. applied for a pension in Jessamine County on August 24, 1818 at the age of 60 years. He enlisted in the Horse Service under Captain C. Jones of the 3 rd Virginia Regiment. He was on assignment at Valley Forge in the year that the Battle of Monmouth was fought. He served for 2 years and was discharged at Guilford's Courthouse. He served on another tour in Dinwiddie County, Virginia. Moore said, "I work at farming for another man and in this way I pay for the house that I occupy. My family consists of my wife, aged upward of seventy years." Daniel Moore died in Jessamine County on July 23, 1839. Mentions: Walker Baylor of Bourbon County, Kentucky; a large amount of family data. (Pension No. R. 7349)

Mosley, Richard	R. W. S. applied for a pension in Jessamine County on September 15, 1823 at the age of 76. He had enlisted into service at New Windsor, on the North River of the Hudson, in New York, in 1775 or 1776. He was discharged at King's Bridge, New York. He served in the battles of Long Island, White Plains, King's Bridge, and several others. He said he owned one old mare and colt worth \$15.00, nothing else except one bed and a few plates. He has no family except his wife who is 68 years old.
Murray, Alexander*	
Neatherland, Benjamin*	R. W. S. applied for a pension in Jessamine County on February 7, 1829. He gave his age as 74 years. He had served in the Revolutionary War as a Lieutenant in the state of Georgia in 1776. His father was John Neatherland, who lived in Powhatan County, Virginia in 1789. Benjamin Neatherland died on October 6, 1838. His widow, Theodosia, applied for his pension on June 19, 1845. She gave her age as 76 years, at the time. She and Benjamin were married in North Carolina in February of 1787. She was a daughter of Ambrose Bramlett. Mentions: James Fergus of Jessamine County; also, Samuel Johnson, who he served with in the war. (Pension No. W. 8487) Note: Buried on the Old County Jail lot, Nicholasville. Born February 29, 1755; died October 10, 1838. Wife, Theodosia, buried here also; born 1766 – died 1852.
O'Neal, George	R. W. S. applied for a pension in Jessamine County on April 25, 1831. He gave his age as 76 years. He was born about 6 miles from Winchester, Virginia in April, 1755. He enlisted into service in Pittsburgh, Pennsylvania in 1775. He moved to Kentucky in 1780. George O'Neal died on October 30, 1836. His widow, Elizabeth, applied for his pension

	on November 19, 1838. She was 71 years old at the time. George and Elizabeth were married on February 15, 1785. Mentions: Bible records; names children and gives dates of birth. (Pension No. W. 2343) Note: buried off Highway 68, Wheeler Farm. Wife, Elizabeth, buried there also.
Overstreet, Henry	R. W. S. applied for a pension in Jessamine County on February 19, 1835 at the age of 70 years. He was born in King Williams County, Virginia on February 2, 1763. He enlisted into service in Hanover County, Virginia on June 1, 1780. After the war, he lived in Hanover and Louisa Counties before moving to Jessamine County, Kentucky. (Pension No. S. 14069)

Prewitt, Byrd*	R. W. S. applied for a pension in Fayette County on October 14, 1830 and gave his age as 76. He said he enlisted in Campbell County, Virginia on January 15, 1776. He was discharged at Valley Forge. He served in the battles of Brandywine and Germantown. Prewitt stated that he, at one time, owned 110 acres in Jessamine County, where he lives. His wife had died 6 or 7 years, prior. They had 10 children, who are now scattered throughout Kentucky and other states. He is now feeble and blind and cannot travel to see them. Note: Byrd Prewitt was the father of Harvey Prewitt, who operated the tavern at Russell's Cross Roads. Byrd Prewitt was married to Sarah Hunt. He also had a brother, Colonel Joseph Prewitt, who was a Revolutionary War Soldier that died in Jessamine County in 1809. Joseph was married two times: first to Leah Moss and then to Polly Price.

Price, William*	The family migrated from Wales to Virginia in 1720. William was born in 1755 near Fredericksburg. He married Mary Cunningham in 1777 and soon afterward joined the American Army as a private. William Price took part in the battles of Brandywine, Monmouth, Germantown, and Stony Point. At Stony Point, General "Mad" Anthony Wayne, his commander, was wounded. Price and some of his fellow soldiers carried Wayne up the hill to see the fall of the fort. Colonel Price was also at the surrender of Cornwallis at Yorktown on October 19, 1781, where he attained the rank of Major. He has always been known by Colonel which we presume was a title in the Kentucky Militia in which he was a member.

Rice, Samuel	R. W. S. applied for his pension in Jessamine County on August 20, 1832 at age 71 years. He enlisted in Charlotte County, Virginia in the summer of 1779. (Pension No. S. 14300)
Richards, James	R. W. S. applied for his pension in Jessamine County on July 17, 1820 at the age of 63 years. He enlisted into service in Lancaster County,

	Pennsylvania in 1775. Mentions: son, Allen Richards. (Pension No. S. 35627)

Robinson, Benjamin	A military marker, dedicated by the Jessamine County Cemetery Project is located in his son, John's, family cemetery on Bethany Road, Jessamine County, Kentucky.
Roman, Isaac*	R. W. S. applied for his pension in Fayette County on February 12, 1833. He said he was a resident of Jessamine County and that he was 77 years old. He stated that he was born on July 18, 1755. He said that he moved westward with his brothers and settled near Seven Mile Ford on the Holston. They lived there until 1797 when he moved to Jessamine County, where he has lived ever since. He said he served under Captain John Campbell, a brother to Colonel Arthur Campbell, in the war. He hired Miles Goforth as a substitute in the Battle of King's Mountain. Goforth was wounded in the knee. He had to give him a fine mare and saddle and bridle, which was more than half his property.
Ross, Daniel	R. W. S. applied for a pension in Jessamine County on June 8, 1818 at the age of 63 years. His widow, Avy Jones Ross, stated that Daniel was living in Fayette County, Kentucky at the time of his death on October 15 or 20, 1835. He had also lived in or near Hardinsburg in Shelby County, Kentucky. Avy Ross applied for his pension on May 30, 1845. She gave her age as 67 years. She stated that they were married in Fayette County on September 5, 1834. Mentions: son, Lewis Ross, age 57 years, living in Jackson County, Indiana. (Pension No. W. 10257) Note: Daniel had enlisted into service in Massachusetts in 1775.

Scott, Thomas	Thomas Scott died on September 24, 1834 in the 80 th year of his age. He lived 44 years in Jessamine County, Kentucky and then moved to Henry County where he lived six years. Death communicated to the Messenger by Thomas J. Scott.
Scott, William	
Sharp, William	R. W. S. applied for a pension in Jessamine County on September 7, 1818. He enlisted into service in Virginia in 1775. William Sharp died on February 23, 1822. His widow, Lucy Sharp, died on January 1, 1834. William and Lucy were married in Stanford County, Virginia in 1785. Mentions: some of their children and their ages. (Pension No. S. 37394) Note: William Sharp had another pension application in Jessamine County on January 15, 1821. He states that he is 69 years old. He enlisted in the Revolutionary War in the 3 rd Virginia Regiment under Colonel Mercer. Mr. Sharp states, "I have no land or property of any kind, except for two pigs, worth about \$2.00."

Simpson, Robert	R. W. S. applied for a pension in Jessamine County on October 19, 1832 at the age of 75 years. He was born in Rockbridge County, Virginia in 1765. He enlisted in Montgomery County, Virginia in March, 1779, near

	Fort Chism. After the war, he lived in Wythe County, Virginia before moving to Kentucky in 1795. Robert Simpson died on April 6, 1834. Mentions: Hugh Simpson, of Warren County, Kentucky, who served with him in the war and knew him in North Carolina. (Pension No. S. 31365)

Walker, James	R. W. S. applied for a pension in Jessamine County on August 18, 1834 at 80 years of age. He was born in Hanover County, Virginia. He enlisted into service in Goochland County, Virginia in 1777 or 1778. He lived in Goochland and Louisa counties before coming to Kentucky. James Walker died on November 29, 1840. His widow applied for his pension in Jessamine County on June 19, 1845. They were married in Goochland County in 1782 or 1783. James Walker was a son of William Walker and Elizabeth Lensy. (Pension No. R. 11036)
Walker, Moses	R. W. S. applied for a pension in Jessamine County on October 13, 1834 at age 69 years. He was born in Bedford County, Virginia on November 15, 1762 or 1763. He enlisted in Bedford County in June or August of 1781. He moved to Jessamine County in 1801. (Pension No. R. 11031) Note: Moses Walker is buried at the head of Indian Creek. Dates on the gravestone are: born November 5, 1763 and died March 27, 1848. His wife, Isabelle, is also buried there. Dates show she was born July 23, 1758 and died June 19, 1837.
